

JOIN THE ARMED FORCES MEDICAL SERVICES AS A MEDICAL OFFICER (SHORT SERVICE COMMISSION) FOR A PROMISING AND CHALLENGING CAREER: 2025 (ONLY ONLINE APPLICATIONS ARE ACCEPTED)

REGISTRATION FOR ONLINE APPLICATION (www.join.afms.gov.in) WILL OPEN ON 19 APR 2025 AND WILL CLOSE ON 12 MAY 2025

- 1. Online applications are invited for the post of Medical Officer (Short Service Commission) in the Armed Forces Medical Services from Indian citizens both male and female, who have passed their final MBBS (Part-I & II) examination in not more than two attempts and have appeared in the NEET PG examination (anytime during the last two years i.e 2023 & 2024). Civilian doctors having a Post Graduate degree will not be required to appear in the NEET PG examination again. Marks obtained by them in NEET PG examination earlier will be taken into consideration.
- 2. **QUALIFICATION** The applicant must possess medical qualification included in the National Medical Council Act, 2019. The applicant must have permanent registration from any State Medical Council/NMC/MCI. Post graduate degree holders recognized by State Medical Council /NBE/NMC can also apply.
- 3. <u>INTERNSHIP COMPLETION</u> Only those candidates who have completed their internship on or before 31 Mar 2025 can apply.
- 4. <u>AGE LIMIT</u> As on 31 Dec 2025, the candidate must not have attained the age of 30 years if holding an MBBS degree (only those born on or after 02 Jan 1996 are eligible) and 35 years if holding a PG degree (only those born on or after 02 Jan 1991 are eligible) respectively.
- 5. **VACANCY** 400 (300 for male + 100 for female).

8. **METHOD OF SELECTION**

(a) SHORTLISTING OF CANDIDATES FOR INTERVIEW

Applications completed in all respects will be further scrutinized/ filtered on the basis of NEET PG entrance examination marks/ percentile. Percentile of the candidates will be proportionately converted into "calculated NEET PG marks" to the tune of 200. For the purpose of obtaining a score out of 200, the percentile score will be treated as marks obtained by the candidate out of 100 and the percentile score will be multiplied by two and the result rounded off to the second decimal and a list will be prepared. In case of those candidates, whose results were declared in absolute score, the percentile score of the candidate will be calculated on the basis of his/her merit position in that exam and the same will be converted into "calculated NEET PG marks" to the tune of 200 as explained above. Candidates will be called up for interview in the order of the list (separate lists for male and female candidates) based upon calculated NEET PG marks upto 08 times of the number of vacancies to appear for viva-voce/ interview.

- (b) <u>INTERVIEW</u> Eligible candidates will be called for interview by a Board of Officers in the month of Jun 2025 at the Army Hospital (R&R), Delhi Cantt to assess their suitability and merit for grant of Short Service Commission in the Armed Forces Medical Services. Candidates appearing for interview for the first time will be paid to and fro AC III/ AC Chair Car fare for journey performed by rail or Govt Non-AC Bus fare for journey performed by road from the normal place of residence to place of interview. In case a candidate is residing in the municipal limit of place of interview no travelling allowance is admissible.
- (c) PHYSICAL & MEDICAL STANDARDS Every candidate on qualifying in the interview will have to attend the Special Medical Examination Board (SMB) constituted by the DGAFMS for examining his/ her medical fitness as per laid down standards. The proceedings will remain confidential. However, candidates declared 'UNFIT' by the Special Medical Board (SMB) may apply for the Appeal Medical Board (AMB). The procedure for AMB will be explained by the President of the Special Medical Board.

Candidates are advised to note that DGAFMS/ DG-1A has no role to play in Appeal Medical Boards (AMB) and the procedure advised by the medical authorities is strictly to be adhered to. The Candidates declared 'UNFIT' by the AMB may apply for the Review Medical Board (RMB). However, Review Medical Board (RMB) will be granted at the discretion of the DGAFMS based on the merits of the case. No representation in this regard will be entertained. Candidates will be considered medically 'FIT' only on receipt of approved medical documents.

Pregnancy, if detected at any stage, after qualification at interview or during pre-commission Medical Examination will render the candidate 'TEMPORARILY UNFIT'.

9. **MERIT LIST**

- (a) All candidates who have qualified in the viva-voce/ interview (by securing at least 50% marks) will be subjected to medical examination immediately after the interview.
- (b) It is to be noted that mere qualifying at the interview does not confirm final selection. Separate merit lists of both male and female candidates, who obtain minimum qualifying marks of 50% in the viva-voce, will be drawn up by adding the "calculated NEET PG marks" (explained in Para 8 (a) above) and marks obtained in viva-voce (maximum 50 marks).
- (c) From the prepared merit lists the candidates declared Medically FIT shall be issued joining instructions for commissioning as SSC Officers upto the number of vacancies available.
- 10. **EMPLOYABILITY** Being a Medical Officer of the Armed Forces Medical Services, the candidate on grant of commission is liable to be posted as per service requirement in any part of the country or abroad, in the Army, Navy or Air Force. They may have to work independently in the unit allotted to them. Even candidates holding PG degree may be posted as General Duty Medical Officer based on Service requirements.

- 11. **EMOLUMENTS** Doctors on commissioning in the Armed Forces Medical Services will be granted the rank of Captain (or equivalent rank in Navy/Air Force) in level 10B of the Defence Pay Matrix of BP Rs. 61300 + MSP Rs. 15500 + HRA (if applicable) as per category of the city, (i.e X, Y, Z, where the officer is posted) + NPA at prevalent rates + Transport Allowance Rs. 3600-7200 as per the category of the city, (i.e X, Y, Z where the officer is posted) + Dress Allowance Rs. 20,000 (Annually) and Dearness Allowance as per prevalent rates. In addition, officers are **entitled ration or ration allowance in lieu** (as per location of Posting & Notification to that effect) subsidized accommodation and allied facilities. PG degree holders are eligible for PG allowance or specialist pay on being designated as Graded Specialist as per **Training Rules** applicable from time to time. In addition, officers are entitled to 60 days Annual Leave & 20 days Casual Leave in a year, Leave Travel Concession (LTC), free Medical Services for self & family including dependent parents, Group Insurance & Canteen Stores Depot (CSD) facility.
- 12. **PROMOTION FOR SSC OFFICER** An SSC officer is commissioned as Capt (or equivalent rank in Navy/ Air Force) on entry and is eligible for promotion to the rank of Major (or equivalent rank in Navy/ Air Force) after four years of service and Lt Col (or equivalent rank in Navy/Air Force) after a total service of eleven years, subject to fulfillment of eligibility criteria. A candidate who holds additional medical qualification of Post-Graduate Degree (MCI/NBE recognized) prior to joining service is eligible for ante date seniority after grant of commission, applicable as per existing rules.

13. TENURE OF ENGAGEMENT

(a) <u>FOR FRESH CANDIDATES</u> The initial tenure of SSC officers commissioned through the civil entry scheme is of five years, extendable by another nine years in two spells, first of five years and second of four years, for those who are willing to continue, subject to availability of vacancies and meeting the laid down eligibility criteria for grant of extension as per extant policy.

(b) FOR EX-AMC CANDIDATES

- (i) Released AMC/ SSC officers will be eligible for grant of fresh tenure of Short Service Commission provided such officers apply within one year of the effective date of their release. The process of selection remains the same as for others as mentioned in previous paragraphs.
- (ii) Candidates released after expiry of 10 (ten) years of SSC service will **not be considered again** for grant of commission in the AMC.
- (iii) Candidates released from the AMC on resignation/ premature retirement will not be considered again for commission in the AMC.

14. <u>DEPARTMENTAL PERMANENT COMMISSION (DPC)</u>

(a) Officers granted SSC will be given three chances for taking up the departmental examination for Permanent Commission after completion of 02 years of service and before completion 9 ½ yrs service irrespective of their age when applying for Departmental Permanent Commission examination, provided they fulfill the conditions of eligibility laid down in the Al 74/76 (as amended), subject to the condition that not more than two chances shall be given in the first tenure of five years. During the second or subsequent tenure, if not done in continuation with the first tenure, no chance for Departmental Permanent Commission will be given.

- (b) The promotional avenues for Permanent Commission officers are given below:-
 - (i) Major 4 years of reckonable commissioned service,
 - (ii) Lt Col 11 years of reckonable commissioned service,
 - (iii) Col By Selection (Approx. 18 20 years of service)
 - (iv) Brig By Selection(v) Mai Gen By Selection
 - (v) Maj Gen By Selection(vi) Lt Gen By Selection

15. PROVISION FOR PG/ SUPERSPECIALITY COURSE

- (a) PERMANENT COMMISSION OFFICER Permanent Commissioned officers having 04 years or more physical service as Capt or equivalent may apply for Advance Specialist/ Post Graduate course for award of MD/MS/DNB Degree as per the extant Training Rules & service requirement of the Armed Forces Medical Services. Permanent Commissioned specialist officers are also provided an opportunity to apply for super specialization training in specialized fields after completion of 04 years as Graded Specialist and having age less than 40 years at the time of applying, selection of which is based on service records and merit in exam conducted by Statutory body. Super specialization can be done in service hospitals or in reputed civil hospitals in India and abroad after seeking placement on Study Leave. The detailment for PG Course/ Super Specialization would be based on organizational requirements as per the extant Training Rules.
- (b) **SSC OFFICER** SSC Officers after release may apply for PG courses (MD/MS/DNB) in AFMS institutions as Ex SSC Officers as per extant Trg Rules amended from time to time. Opportunity for In-service PG may also be available as per the extant Training Rules.
- 16. **HOW TO APPLY ONLINE** Application will be accepted online only. To do so the candidate needs to click on the "NEW REGISTRATION" button and follow the steps given on the website www.join.afms.gov.in.

- (b) Following original documents are essentially required to be produced for verification at the time of interview:-

- (viil) No Objection Certificate from present employer, if any

- (x) National Board of Examination Certificate for Foreign Medical Graduates
- (xi) Passport for Foreign Medical Graduates
- (xii) Gazette Notification or any other authority clearly highlighting your new name, if there is any change in the name after Matriculation (Class X)
- (xiii) 10 Passport size photographs (not older than 06 months), photo identity proof and address proof
- (xiv) Attestation Form in five copies duly filled in and attested by Competent Authority (Refer Para 19 below)
- 18. <u>ADMIT CARD FOR INTERVIEW</u> The Admit card for interview shall be made available for download on website <u>www.join.afms.gov.in</u> at least one week prior to the date of commencement of interview.
- 19. An Attestation Form is available on the website. Candidates are required to bring the Attestation Form (five copies) at the time of interview, duly filled in and attested by the Authority as mentioned at Page No. 07 of Attestation Form, in original, without which, they are liable to be rejected.
- 20. <u>APPLICATION PROCESSING FEE (APF)</u> A Fee of Rs. 200/- will be charged from applicants towards the application processing. The requisite amount is required to be paid at the end of the application submission through online payment (internet banking/Credit Card/Debit Card). No other mode of payment is acceptable.
- 21 The information contained at para 10 to 15 above are based on the present provisions in various rules/regulations on the subject. These are subject to change based on exigencies of service and as amended from time to time by the Government.
